

GUIDANCE NOTE 8 Profiles

Profiles

What is a Company Profile?

A Company Profile is a summary of the latest information on a Company. This includes:

- Registration Number.
- Name of Company.
- Incorporation Date.
- Date on which the last Annual Return was filed.
- Year-end date of last Accounts / Abridged Balance Sheet filed.
- Registered Office address.
- Status of the Company i.e. whether it is in liquidation, pending striking-off or has been struck-off.
- Details of Share Capital.
- Details of Shareholders.
- Details of Directors.
- Details of Secretary.
- Details of any Charges registered against the Company.

Who can request a Company Profile?

Any member of the public can request a Company Profile of any Gibraltar registered company.

How much does a Company Profile cost and when can I expect to receive it?

The fee for a standard Company Profile is £17.50. This would be ready the following working day and can be sent to you by email (as a PDF document) or it may be collected from the Registry between 10:00am and 3:00pm.

The fee for a certified Company Profile (certified by the Registrar of Companies) is £22.50. A certified Company Profile would have to be collected from the Registry the following working day between 10:00am and 3:00pm. If requested from outside of Gibraltar, this can be sent by post.

How can I request a Company Profile?

A Company Profile can be requested by completing the Profile Request Form at the end of this circular and sending it by email to profile@companieshouse.gi.

How can I pay for a Company Profile?

Registry users with a Deposit Account with Companies House Gibraltar can choose to have the fees

debited from their Account.

Users who do not have a Deposit Account can send the request form by email to profile@companieshouse.gi and settle the fee by credit/debit card, or by delivering the completed form to

the Registry between 10:00am and 3:00pm and settling the relevant fee in cash or cheque. Cheques

should be made payable to Companies House Gibraltar.

* Please note that all major credit and debit cards can be accepted, however we do not accept payment

by American Express cards.

NB. As many companies have similar names, please make sure you give the full name of

the company, including any initials. If you are able to quote the company number, this

will also help us to process your request.
