TAKE NOTICE that the **Fifth** and **Seventh** Supplement are published as supplements to the Gibraltar Gazette.

 1. Particulars required to be Gazetted under Section 430 of the Companies Act.

- **The SEVENTH SUPPLEMENT** includes
 2. Particulars required to be Gazetted under Section 411 of the Companies Act:-
 - i. First Notice of Striking Off
 - ii. Final Notice of Striking Off

 3. Particulars required to be Gazetted under Section 412 of the Companies Act:-

 4. Particulars required to be Gazetted under Section 413 of the Companies Act:-

6. Particulars required to be Gazetted in respect of the winding up of a company.
7. Particulars to be Gazetted under the Interpretation and General Clauses Act Section 8a and the rules thereof.
8. Particulars to be Gazetted under the Companies (Re-domiciliation) Regulations 1996 (as amended).
 - i Certificate of Re-domiciliation into Gibraltar pursuant to regulation 4 (3)
 - ii Notice that a re-domiciled company has been struck off the register pursuant to regulation 5 (3) (b)
 - iii Notice of Application for consent to Re-domicile out of Gibraltar pursuant to regulation 7(4)
 - iv Notice of Cessation pursuant to regulation 10 (3)
