## DECLARATION OF OWNERSHIP BY A BODY CORPORATE

Please read these notes and refer to them as necessary when completing this form

- \* Please write in black ink using BLOCK CAPITALS, and tick boxes where appropriate.
- \* A share can be owned jointly by no more than 5 persons.
- \* For the purposes of registration, the property in a pleasure yacht is divided into 64 shares.
- \* A pleasure yacht is entitled to be registered on the Register of Ships if the majority interest (ie, 33 shares) is owned by persons qualified to be owners of a pleasure yacht registered in Gibraltar:
  - A. Bodies corporate incorporated in an EEA State(\*) and having appointed a representative person;
  - B. Bodies corporate incorporated under the Law of Gibraltar and having their principal place of business in Gibraltar or having appointed a representative person;
  - C. A Foreign Maritime Entity
- \* Joint owners of a share must all be qualified persons for that share to count towards the 33 shares required for majority interest.
- \* Any number of persons may be registered as joint owners of a pleasure yacht or of any share in or any part of the pleasure yacht, but any such joint owner is not entitled to dispose of that interest in severalty
- \* Representative person
  1. If the owners making up the majority interest are resident in Gibraltar, a representative person must be appointed. A body corporate shall be treated as resident if it has a place of business in Gibraltar.
  2. A representative person is either an individual resident(†) in and having a principal place of business in Gibraltar or is a body corporate incorporated or registered under the Laws of Gibraltar and having its principal place of business in Gibraltar and having as a part of its business acting as a representative person.
  3. The representative person must consent to his appointment in writing. Any changes of name, address or representative person must be communicated to the Registrar within seven days of such.
- \* If the vessel is registered abroad you must take all reasonable steps to remove the vessel from the foreign register before completing registration. Failure to comply with this requirement can result in a fine.
