

# **GUIDANCE NOTE 3**

# Opening an Account with Companies House

**Updated January 2022** 

Opening an account with Companies House will allow users to experience a more efficient service for over the counter or email requests. Should the user also apply for an Online Account, he would be able to enjoy the ever-growing number of services offered via our e-registry platform.

#### **Deposit Account**

A deposit account gives users the ability to deposit funds in their accounts for the exclusive use of any service offered by the Registry that requires payment. Users with a deposit account are then able to authorise Companies House to debit the required amount from their account without any further action necessary from themselves.

The deposit account service operates as follows: -

- All users with deposit account will be given a customer account number.
- Accounts will be debited accordingly after every transaction, (clients will be requested to authorise each transaction as confirmation that they requested that particular service).
- If there are insufficient funds in the account, it will not be possible to provide the service.
- Statements are available on request and may be obtained from our website for account holders who also have an Online Account.
- This facility is free of charge.

When funds are deposited into an account, Companies House will issue a deposit receipt containing the following details:

- Customer's name and account number;
- Receipt number;
- Receipt date and time;
- Operator's name; and
- The amount deposited;

#### Online Account

By opening a deposit account with Companies House, you can also thereafter apply for an Online Account to make use of the numerous online services offered by the e-Registry.

The Online Account would allow you to do the following:

- Search for entities by name or registration number;
- Obtain limited information on any registered company, such as the company's registration number, the status of the company, the type of company and the last Annual Return filed date;
- Download copies of documents filed (including accounts), or full archive bundles;
- Download Profiles and Mortgage Profiles;
- Conduct eSearches (as if carrying out a physical search of the file at the Registry);
- The possibility to file most documents electronically;
- Make use of the e-Monitoring service, whereby you can apply to monitor companies, and the Registry is able to send automated emails when any of these companies conducts any of the specified activities. See Guidance Note on eMonitoring

- Access to all our 5<sup>th</sup> & 7<sup>th</sup> Supplement publications in the Gibraltar Gazette, containing the following:
  - o First Notice of Striking Off (pursuant to Sections 411,412 and 413 of the Companies Act);
  - o Final Notice of Striking Off (pursuant to Sections 411,412 and 413 of the Companies Act);
  - o Notices pursuant to Sections 414 regarding notices of Restorations of Companies to the Register;
  - o Notices of Dissolution in respect of winding up; and
  - o Particulars under the Companies (Re-domiciliation) Regulations 1996 (as amended).

Note: There is a monthly subscription fee of £10 for the online account. Some of the services mentioned above also carry a fee, which will be clearly displayed before you purchase the service.

#### E-Filing

Companies House Gibraltar also operates an e-Registry, which is only available to online account holders who are either individual Directors and/or Secretaries of Gibraltar registered companies, or authorised officers of corporate Directors and/or Secretaries.

To take advantage of e-Filing, the Director(s)/Secretary(ies) would need to apply for a UID (Unique Identifier) number completing the attached forms.

Documents filed electronically are automatically validated to form part of the company's records, which are then available for inspection/download within 24 hours.
