### IMPORTANT INFORMATION

Every Business Name must submit an Annual Statement of Particulars Form (Annual Return) at least once a year. The fee for lodging an Annual Return in time is £15.00. The lodging of an Annual Return after 30 days from its due date, or a substitution of an Annual Return after the due date for filing, carries a fee £30.00.

Together with the completed form the applicant must submit:

- **Proof of identity of the proprietors (if individuals - I.D. cards or passports, if a corporate entity not incorporated in Gibraltar, a certified copy of the Certificate of Incorporation (or equivalent) and evidence of Good Standing.**
- **Proof of addresses of the proprietors (e.g. a recent utility bills – not more than three months old).**
- **Proof of 'right to use' the address where business is stated to be located or trading from (e.g. utility bill, a lease or tenancy/rental agreement or a letter from the persons in control of that address authorising the use of their address for commercial purposes).**
